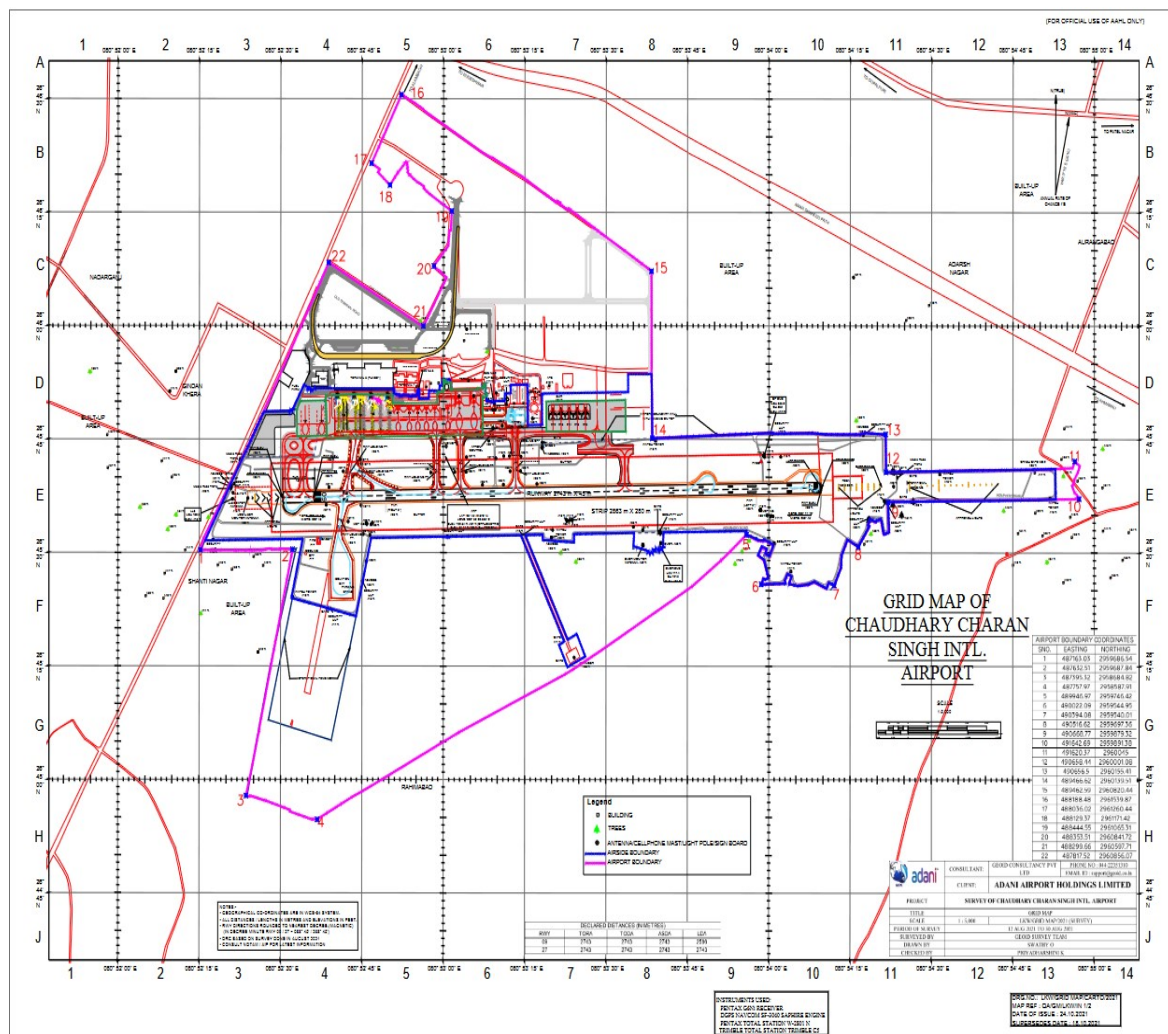
(A) CCSI AIRPORT, LUCKNOW -DECLARATION OF CUSTOMS AREA

Consequent upon the issuance of Notification No.05/99-Cus(NT) dated 27.01.99 declaring thereby the Lucknow Airport as Customs Airport, and in supersession to Public Notice No. 01/99 dated 02.02.1999, I, Ranjeet Kumar, Commissioner of Customs (Preventive) Commissionerate, Uttar Pradesh and Uttarakhand by virtue of power vested in me under Section 8(b) of the Customs Act, 1962 (5 of 1962) in so far as they relate to the Lucknow Airport, hereby declare the following area as the limits of the Customs Area:

The Whole of the Aerodrome situated in an area of 1258.80 acres including the runway, tarmac parking space, building, fuel installation, offices, structures and vacant land in a zig-zag formation bounded by the following and specified in the layout map annexed:
