- 1. Attention of all Exporters/Importers, Custom House Agents and Trade is invited to the above mentioned subject.
- 2. Precursor Chemicals are the substance, which have been identified as having the potential to be abused in the illicit manufacture of Narcotic Drugs and Psychotropic Substances. The Export/Import of Precursor Chemicals is governed by the Narcotic Drugs & Psychotropic Substances (Regulation of Controlled Substances) Order dated 26.03.2013.
- 3.The Narcotics Commissioner of India, Central Bureau of Narcotics (CBN) is the designated Competent National Authority (CAN) for the issuance of No Objection Certificate for the export of Precursor Chemical from India and Import of Precursor Chemical into India.
- 4.All the Exporters/Importers, Customs House Agents, Traders are hereby informed that the exports/imports of the Precursor chemicals would have to be accompanied by the necessary No Objection Certificate from the Central Bureau of Narcotics, Gwalior.
- 5.Non-compliance of the above mentioned requirement would attract Penal action under Customs Act 1962, or/and under any other law for the time being in force in India , including the Narcotic Drugs and Psychotropic Substances (Prevention) Act, 1985.
